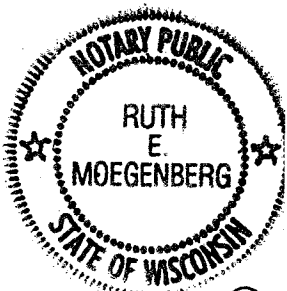

To: Ozaukee County Board of Supervisors

Dear County Supervisors,

The oath that each of you take prior to entering office states that you will support the Wisconsin Constitution and the United States Constitution. Your oath presupposes that you have read and understand those documents, most importantly the first ten amendments known as the Bill of Rights.

Your oaths on file with the county clerk are sealed with the operative statement "So help me God." The oath, "taking the name of God." is a pledge and the binding force behind a contract, which is only as good as the pledge of its maker (you). Violation of this oath is to take the name of God in vain. To swear an empty or hollow oath, one that is false and meaningless - is to commit perjury, by definition. Perjury is a very serious crime. Perjury is that serious - that deadly to the security of the social order and thereby to the lives of men.

"the Lord will not hold him guiltless that takes His name in vain." (Exodus 20:7)

God's authority is the basis upon which the civil law requires that testimony be given under oath. The authority of law in America is plainly God, the Father of Jesus Christ. While the constitution forbids sectarian religious tests for holding public office, officials must swear by God. To do so is to acknowledge the Creator and that all authority not only comes from Him, but also that man's delegated authority must therefore be exercised in all honesty and godliness, without exception.


Note: Responsibility comes with authority.



Matthew 10:28). "The fear of Lord is the beginning of wisdom: (Psalms 111:10)." Those who disregard these Scriptures is like a man who says he doesn't believe in gravity. **Affidavit of Criminal Report and Probable Cause

I, Steven Alan Magritz, hereinafter Affiant, who is currently incarcerated at Stanley Correctional Institution, Stanley, Wisconsin, states that Affiant is of legal age, competent to testify, has personal first hand knowledge and believes that the truths and facts herein are true, correct, complete, certain, not misleading.
